The insurance does not apply to pregnancy.

From 25 May 2018, the new Data Protection Regulation (GDPR/EU regulation) applies.

The GDPR/EU regulation replaces the existing Personal Data Act (PUL) and applies to all EU

countries.

In Sweden, it is the Data Inspectorate as a government authority which, through its

supervisory activities, must contribute to ensuring that the processing of personal data does not

lead to unauthorized intrusions into the personal integrity of individuals. Further information on these

matters is available on the authority's website.

We at the foundation see it as a matter of trust that your personal data and sensitive data are processed

correctly according to the EU's data protection regulation (GDPR) and would like to inform you

about the processing of personal data because you are part of Rotary's youth exchange program. We

need to process your data in order to administer your part of the Rotary youth exchange program.

Our endeavor is that all our processing of personal data must always be compatible with the new

Data Protection Regulation.

Personal **data** is information that can be directly or indirectly linked to a physical living person.

Examples of

personal data are name, address, telephone number and e-mail address.

Sensitive personal data is data that reveals racial or ethnic origin, political opinions, religious

or philosophical beliefs, trade union membership and personal data relating to health or sexual

life. Information about health can e.g. be sick leave, pregnancy and doctor's appointments.

Processing of personal data includes all handling of personal data, such as collection,

registration and storage.

The person responsible for personal data is the person who, alone or together with

another, determines the purposes and means for the processing of the personal data and

who is ultimately responsible for the processing taking place in accordance with the

applicable personal data legislation.

Who is responsible for the processing of your data?

It is the foundation that is responsible for the processing of your personal data. If you

#### What personal data do we collect?

For those of you who are participants in one of our exchange programs, the foundation collects data via data media or paper forms primarily directly from you. It concerns

Name, social security number, gender, address, e-mail address, telephone number, relatives, school grades, life description, passport and information on medical health status.

For you who are a relative, host family, functionary or employee within the foundation, host district in Sweden or abroad or host club Sweden or abroad connected to our exchange programs, the foundation collects information via data media or paper form primarily directly from you. It concerns

Name, social security number, gender, address, e-mail address, telephone number and relationship to a participant in one of our exchange programs.

This information may be supplemented and updated by a functionary or employee within the foundation, host district in Sweden or abroad or host club Sweden or abroad in connection with our exchange programs.

#### Why do we process your personal data?

As a prerequisite for you to be able to participate in one of the foundation's exchange programs, we register information about you to manage your exchange, produce data for statistics and billing and offer you good opportunities for contacts.

#### What legal basis do we have for processing your personal data?

The foundation primarily processes your personal data to fulfill its obligations according to the entered into agreement on participation in one of our exchange programs. For other purposes, we process your personal data because the foundation has a legitimate interest in being able to provide a good service to participants in one of our exchange programs.

## How long do we process your personal data?

Your data is saved for three years after the end of your exchange year. After three years, your personal data will be deleted. Your contact details are also saved after three years.

### Disclosure of your personal data

The foundation releases personal data including personal and contact details to Rotary International in the USA as well as host clubs, host districts and host families abroad. It is a prerequisite for participating in one of our exchange programs. To a limited extent, contact details can also be disclosed to partners within Rotary, e.g. alumni networks, Rotaract and other Rotary organizations or travel agencies and insurance companies.

In cases where the foundation uses external parties to handle administration (e.g. invoicing), information is handed over to them to the extent necessary and then regularly established

## personal data processing agreement

## Your rights

- You have the right to receive information about the processing of your personal data free of charge once a year . Such a request is sent to the foundation.
- You can also request that personal data be corrected, deleted or blocked by contacting the foundation. However, deletion before or during an ongoing exchange may mean that the exchange is terminated prematurely.
